PUBLIC NOTICE**

TAKE NOTICE that pursuant to Section 48 of the Municipal Act, 2001 S.O. c. 25, as amended, the Council for the Corporation of the Municipality of McDougall proposes to enact a By-law to change the name of ten(10) Municipal roads set out and described as follows:

That being the road named and known as Fire Route 303, lying in Concession 2, Lot 22 & 23, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 303 and to be re-designated and renamed as **MILL HEIGHTS ROAD**.

That being the road named and known as Fire Route 303A, lying in Concession 2, Lot 22 & 23, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 303A and to be re-designated and renamed as **STENFOR' S ROAD**.

That being the road named and known as Fire Route 211, lying in Concession 10, Lot 13 & 14, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 211 and to be re-designated and renamed as **RAMBLING ROAD**.

That being the road named and known as Fire Route 106, lying in Concession 7, Lot 24, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 106 and to be re-designated and renamed as **DRAPER DRIVE**.

That being the road named and known as Fire Route 211A, lying in Concession 9, Lot 12 & 13 and Concession 10, Lot 13 in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 211A and to be re-designated and renamed as **WITCH' S BROOM TRAIL**.

That being the road named and known as Fire Route 316, lying in Concession 9, Lot 11 & 12, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 316 and to be re-designated and renamed as **DRAGONFLY LANE**.

That being the road currently named and known as Fire Route 315, lying in Concession 9, Lot 10, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 315 and to be renamed and re-designated as **KINGFISHER ROAD**.

That being the road named and known as Fire Route 208A, lying in Concession 12, Lot 19, 20, 21, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 208A and to be re-designated and renamed as **REDBEA TRAIL**.

That being the road named and known as Fire Route 205, lying in Concession 4 & 5, Lot 20, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 205 and to be re-designated and renamed as **BURNSIDE BRIDGE ROAD**.

That being the road named and known as Fire Route 110, lying in Concession A, Part Lots 5 and 6, in the geographic Township of McDougall, now in the Municipality of McDougall, in the District of Parry Sound and now designated as Fire Route 110 and to be re-designated and renamed as **VALLEY STREAM DRIVE**.

The proposed By-law will come before the said Council for consideration at its regular public meeting at the Municipal Office, in the Municipality of McDougall at #5 Barager Boulevard, R.R. #3, Parry Sound, Ontario, P2A 2W9, on the 28th day of July, 2010 at the hour of 7:00 o' clock in the evening, and at that time, the Council will consider the comments, submitted orally or in writing, of any person or by his Counsel, solicitor or agent any person who claims that his/her or its land will be prejudicially affected, and who applies to be heard. Written comments may be submitted to the person named below at the address indicated below prior to the public meeting.
